## **FOR MILITARY AND LAW ENFORCEMENT**

*This program is available to qualified members of the military and law enforcement in the United States Only; not open to U.S. Territories.*

### **PATRIOT + PROTECTOR PROGRAM OVERVIEW:**

- This program is designed to give access to Law Enforcement, Military, and First Responders access Shadow Systems pistols at a deep discount.
- We have developed this program in partnership with Distributors to give retailers easy access to discounted pistols in order to serve their local Law Enforcement, Military, and First Responder community.
- This program is designed to be fulfilled by the retailers so that Law Enforcement, Military, and First Responders can have access to these discounted Shadow Systems pistols within their local communities and without long lead times.

### **PATRIOT + PROTECTOR PROGRAM QUALIFIED PURCHASER, WITH PROPER ID:**

- Sworn LEO (Law Enforcement Officers) State, County and Local
- Federal LEO - F.B.I., U.S. Marshals, DEA, DHS, et cetera
- A cadet or recruit in an approved Law Enforcement Training Academy with proof of attendance or acceptance to Academy
- Corrections Officers, including Parole and Probation Officers
- Retired LEO with “retired” credentials including Federal, State, County and Local
- State Licensed Security Companies and State/City Licensed Security Officers
- Federal Flight Deck Officers
- Court Judges, District Attorneys and Deputy District Attorneys
- First responders including firefighters and rescue personnel with appropriate I.D.
- Military: Active, Retired, Active-Reserve, Disabled in any capacity, Active – Nat’l Guard, Veteran with DD-214
- School Defenders: Faculty, Teachers and Staff authorized by the School District to carry a firearm at their school must provide a letter from the School District that authorizes the School Defender to carry. A copy of the letter must be provided to Shadow Systems

# PATRIOT + PROTECTOR PROGRAM

---

## DEALER REQUIREMENTS

- Eligible Dealers must register as a Patriot + Protector Program Dealer using the Dealer Application Form in this packet and submit to a participating P&P Distributor, along with the initial order.
- Dealer applications will be processed within 30 days of receipt of form.

A dealer is eligible for participation if it meets the following criteria:

- Holds a valid and current FFL for a stand-alone business not located on the same deeded property as a home or dwelling
- Operates as a Shadow Systems Stocking Dealer, willing to serve both consumer market and officer program
- Has regular business hours, knowledgeable sales personnel, and reasonable post-sales service
- Dealer must also stock a minimum of 4 P&P units for sale at all time.
- Patriot + Protector Program Dealers will be listed as such on the Shadow Systems website
- Dealer staff must participate in dealer training program within the first 60 days of acceptance of application
  
- A Patriot + Protector Program Customer Verification Form must be provided by the dealer to Shadow Systems at patriotprotector@shadowssystemscorp.com with each purchase through the program.
- Eligible end user customers may purchase up to four (4) firearms per year with the discounted program pricing.
- The following types of sales are NOT permitted through this program: Agency or Departmental sales, internet sales, gun show sales. NO prices may be shared on the Internet.
- Shadow Systems reserves the right to revoke a Dealer's access to the Patriot + Protector Program at any point if the above requirements are deemed by Shadow Systems to no longer be met. A participating dealer agrees to allow Shadow Systems representatives to visit the dealer location for inspection and/or verification of compliance with these requirements.
